Annual Report

The Chair thanked the Public Relations Committee and specifically Nancy Saul-Demers for pulling together all of the information in the 2010-2011 Annual Report that had been distributed to all in attendance.

Chair's Report

Audrey Conroy reported that we are in the second year of the three-year provincial funding of \$10,000. This funding allowed ACC to hire a part-time Theatre Manager in January, 2011 in the person of Kathleen Hull. A. Conroy thanked fellow Board members for their contributions throughout the year.

The chair thanked the 100th Anniversary Committee and the PR Committee for its efforts in organizing and promoting the anniversary year. Everyone was encouraged to purchase an anniversary mug and to attend the final event of the year "Gone with the Wind". Special thanks were given to Bill Zimmerman and Susan Hauer for researching, writing and to Steven Slipp for producing the exhibit panels. The images on the panels were made possible by loans from the Acadia Archives, Ken Bezanson of Port Williams and Coop members.

A. Conroy presented an award to Al Whittle from the Annapolis Valley Events & Sports Tourism Association for Venue of the Year.

Corporate Secretary's Report

F. Chipman read the following report that was included in the published report: The ACC currently has 665 shareholders holding a total of 3259 shares.

The Sink the Mortgage Plan, initiated in 2008, suggested shareholders purchase one share in each of the next three years with the goal of returning the mortgage by 2011. In Nov. 2008 the mortgage stood at \$227,000.

The results to date:

July 1, 2008 – June 30, 2009 – 251 shares purchased by 120 shareholders

July 1, 2009 – June 30, 2010 – 152 shares purchased by 78 shareholders

July 1, 2010 – June 30, 2011 – 117 shares purchased by 47 shareholders

July 1, 2011 – present – 1055 shares purchased by 23 shareholders

Although this is still not enough to retire the mortgage by the end of 2011, I am confident that we will be able to eliminate (our part of) the mortgage when we renegotiate it in Oct., 2012. The current ETC share sale continues until Feb. 28, 2012, and your purchases will help ensure we reach our goal.

MOTION to adopt Corporate Secretary's report: Moved: F. Chipman, seconded: I. Madeira-Voss CARRIED

Financial Statements:

Our new auditors were introduced and Bishop & Company, Chartered Accountants Inc. were represented by Loretta Kalkman.

Clarification was requested as to how the coop was doing financially by a shareholder who admitted he did not understand the accountants numbers. The answers were provided by L. Kalkman who answered that how the coop is doing depends on its goals. K. Hull answered that as a not-for-profit our goal is not to make profit but to provide the best facility to the community. A. Conroy quoted Kathleen Hull that by this measure the ACC is the healthiest cultural group she knows of in the Valley.

Nomination Report:

S. Slipp reported, as member of the Nominations Committee with K. Malim and F. Chipman, that the majority of the Board were returning next year. There were three ACC Board positions vacated by Directors. The new nominees to the Board (Paul Callaghan, Gerry Parker and Mark Crosby) were introduced and their brief biographies read aloud. No further nominations were made after three calls for nominations were voiced.

MOTION by Lorne Saul-Demers that the nominees be elected by acclamation. Seconded by A. Conroy. CARRIED

A. Conroy thanked the nomination committee for their work.

Other business

Noemi Volovics wanted to inform shareholders of the need to fund new technology for film distribution and projection which is already having an impact on the choices of films available to Fundy Film and the Slow Motion Film Festival who rent the Al Whittle. She asked that the board budget for this eventuality. A. Conroy thanked her for the concern and noted it was before the board and a response was forthcoming.

Meeting adjourned at 8:30 pm on motion by: I. Madeira-Voss

After the AGM there was a facility tour given by Kathleen Hull, and a tour was made of the 100th Anniversary exhibit in the lobby.

2012 Annual Report Message from the board of directors

Welcome to our 2012 Annual Meeting.

International Year of Cooperatives 2012

This is another occasion for us to celebrate 2012 as the International Year of Cooperatives. As a participant in the fledgling Valley Cooperatives Network, we are celebrating this year with two major events – a picnic which was held in August, and a Market Meal & Film Night here tomorrow evening. See the poster elsewhere in this report for details.

Theatre Manager

This has been a year of adjustments for our co-operative. We lost our first part-time manager after less than one year when Kathleen Hull resigned as of January 1. We were fortunate after a rapid search effort to select a new manager from a field of about a dozen applicants. Mary Harwell took up her post as of February 1, and has been active since then with managing bookings and learning the ropes. Mary is a career stage manager and has owned and operated Tempest World Cuisine with her husband chef Micahel Howell since coming to Wolfville.

Planning and Priorities

2011-2012 activities included a board-building process of determining our priorities over the next 3 years. The results provide guidance to our various committees.

Our top priorities are clear:

- 1. Reduce debt
- 2. Find additional revenues by better promoting the theatre as a rental venue
- 3. Actively seek community investment from share sales and donations

Finances

We are in the final year of a 3-year operations grant from the Province of Nova Scotia. This funding was instrumental in our hiring a part-time theatre manager. The Town of Wolfville has also provided ongoing support for our community-owned venue. Next year's budget has been prepared, and we will monitor actual vs budgeted monthly

Rentals have been stable for the last 3 years, and we are now actively promoting the Al Whittle and Studio-Z for rentals with a goal to increase these by a minimum 10%.

Essential to our continued operations, grants, share sales and donations will be actively sought to help avoid budget shortfalls and ensure timely pay-down of our debts.

Joint Management Committee

This is a quarterly management meeting with Just Us! to look at building maintenance and repairs, and the larger view of how we can provide better levels of service to our joint customers. This group meets to review building issues and to maintain good communications at both the board and staff level.

Wrap up of 100th Anniversary celebration




Between events and merchandising the Centennial Celebration raised both funds and awareness to assist ACC with building maintenance projects and equipment repairs and upgrades.

ACC Centennial travel mugs were sold at many events and continued to be sold through Just Us cafe until the end of June 2012. Posters and post cards were also available at various ACC sponsored events. Please note that mugs (\$20) and posters (\$5) are still available for purchase – see Theatre Manager, Mary Harwell.

The exhibit of the history of the theatre was displayed in Jack's Gallery again this year in Sept 2011. The attractive panels are very useful for telling the story of the theatre and its evolution over the years. They have been pulled out many times this year for educational and fundraising events.

Technical Advisory Committee

We instituted a new volunteer committee this year with the help of several experts in the areas of lighting, sound, projection, IT and structural building technologies. This committee of voluteers has agreed to advise the theatre manager and the board on technical matters, and has already completed an inventory of equipment and audit of repairs and maintenance.

Occupational Health & Safety

Our Human Resources committee has been active developing policies and procedures to meet appropriate standards for OH&S for our theatre employee and event contractors. Watch for more on this in the coming year.

Digital Cinema Server

You may have heard how quickly film projection technology is changing. We have been hosting a mix of half-and-half 35mm film and DVD/BluRay disks, but that is rapidly coming to an end. As of January 2013, almost all cinemas in Canada and the U.S. will no longer receive 35mm prints of major films and documentaries; in fact most have already converted. Films will all be distributed through digital technology and shown from a secure server running a digital projector.

In 2009, with assistance from ACOA and the Province of Nova Scotia, our then-new digital projector enabled us to show DVD and BluRay video. Fortunately that projector has the ability to upgrade easily to the new secure server technology.



We need to make a capital outlay of \$18,000 this Fall so we, and our key tenant Fundy Film, can continue to screen first-run films. However, this is outside of our budget for 2012-2013. We are asking our existing and new shareholders to contribute to this capital investment and keep Acadia Cinema plugged in to current world cinema with this digital cinema upgrade.

Nova Scotia Equity Tax Credit (ETC)

We have applied for and received another ETC to enable us to solicit community investment in the Acadia Cinema Cooperative. This ETC runs until the end of February 2013 and we hope in increase the number of new shareholders and share purchases this year. Join the almost 700 ACC shareholders in our community.

Theatre Manager's Report

This year the theatre has faced many challenges and accomplished much. Highlights:

- Established a Technical Advisory Committee to assist with all major decision making for repairs and upgrades for the building
 - Worked on creating a more accurate inventory of equipment
- Worked toward training a new event manager so that we have 3 trained event managers for events
- Continued general repairs of building and equipment:
 - Roof repairs
 - Floor threshold between café and lobby repairs
 - Fluorescent lighting repairs in studio
 - General upkeep of air filters and cleaning
 - Emergency lighting serviced
 - Annual certifications for high tech equipment
 - marquee neon serviced and repaired
- Efforts to enhance communications with our shareholders, presenters, performers and audiences include:
 - Website link with Valley Events, so that events automatically transfer information from valleyevents.ca to both the Al Whittle website and Al Whittle Facebook page
 - Clean up of the Al Whittle presence on Facebook so that there is only one page with all information
 - board sent a mid-year report to keep shareholders informed of important news and developments
- Worked to establish an OHS policy and ensure that the theatre is OHS compliant
- Worked to develop ways to promote the theatre as a rental house, including simplifying the rate sheet and creating a new rack card to distribute to potential renters
- Worked to finding ways to raise funds to support and maintain the building including:
 - Just Us Café and ACC worked together to present a variety show, "A Whittle Off-Broadway" in the spring of 2012. Funds raised from the show are being applied to special building projects.
 - Just Us created a special ACC chocolate bar, and Steve Slipp designed 4 special Al Whittle Theatre related wrappers. Funds generated from the sale of these bars will go towards special building projects as well.
- Before Kathleen Hull's departure in January, there was work done on creating a 3 year plan to guide us through 2012/13 to 2014/15. This priorities list will help us focus our energies and resources on specific tasks and projects for each of the coming 3 years.

As of June 30, 2012 our organization had:

- 696 Shareholders holding 4,368 shares
- An enthusiastic and active group of volunteers, supporters and a dedicated board of directors.

- One year remaining in a 3-year funding commitment of \$10,000/year from NS Tourism, Culture and Heritage.
- A part-time manager

Corporate Secretary's Report

As of June 30, 2012 the ACC had 696 shareholders holding a total of 4,368 shares.

For the fiscal year July 1, 2011 – June 30 2012, 54 shareholders purchased 1109 shares.

This continuing demonstration of community support has allowed us to significantly reduce the principal on our mortgage and has put us in a position to continue reducing other debts. Details of our remaining debt will be highlighted in year end Finance Committee report

Nova Scotia Equity Tax Credit share offering

We currently have a new Nova Scotia Equity Tax Credit (ETC) for share purchaes, ending March 1, 2013. This provides purchasers of new shares a 35% tax credit for their share purchase investment in our community cultural asset.

It is hoped that funds from this sale will cover the cost of the recently installed DCP server.

Finance Committee Report

Operating Grants

We recognize the support of the Province of Nova Scotia through the Department of Tourism, Culture and Heritage. We are pleased to work in partnership with the Culture Division to develop and promote out cultural resources for all Nova Scotians. This year, we received the second year of a \$10,000 annual operating grant from the province and we have a commitment of \$10,000 for this next fiscal year as well.

The organization also benefited from a \$5,000 facility grant for the fiscal year from the Town of Wolfville's Community Partnership Program.

Financial Highlights – 2011/12

- Major progress in eliminating mortgage; principal reduced from \$147,000 to \$38,800
- Stable rental income over the past 3 years
- Terms established to pay off loan to ACC shareholder (\$61,400 over 10 years @ 5%)
- Met financial obligations in first full year with salaried part-time manager in place

Moving Forward - Debt & Capital Funding

- Mortgage renewed 10/01/2012;
 - 3 year term @ 3.95% (\$30,107 amortized over 8 years)
- Loan to ACC shareholder renewed 07/01/12;
 - 10 year term @ 5% (principal = \$61,300)
- As of 10/01/2012; total LTD = \$89,600 (mortgage + loan)
- Other debt; \$3500 loan from Fundy Film & offer of \$10,000 line of credit from member of ACC Board (purchase of Digital Server)

Key Implications;

- · Substantial decrease in interest expense
- Beyond interest expense, operations have limited capacity to support capital investments (past & future)
- Continued dependence on fundraising and/or share sales to meet capital financing obligations.

Moving Forward - Operational Revenue & Expenses

- Efforts to grow rental income
- Anticipate increase in building repair & maintenance expense
- Operating grants from the Province of N.S. and Town of Wolfville remain vital


