CORPORATE SECRETARY REPORT: Fred Chipman

- Fred reported that 4,673 shares had been sold to date. During 2014-2015 shareholders purchased 64 shares.
- This year's shareholder drive will close on February 28, 2016, with proceeds going towards the purchase of theatre lighting, and debt reduction.

FINANCIAL REPORT: Paul Callaghan

Paul presented the ACC Financial Statements.

- It was noted that we have one more year to receive an operating grant of \$10,000 from the province of Nova Scotia's Operating Assistance to Cultural Organizations.

Message from the board of directors

We have continued to receive essential shareholder, community and government support which enables operation of the Al Whittle Theatre, Studio-Z, Jack's Gallery and our overall building. Board members work on behalf of shareholders to direct operations at the Al Whittle Theatre with our excellent part-time manager. It is our role to ensure this venue operates sustainably; offers an accessible, affordable venue; and provide presenters with excellent technical support services.

ACC shareholders, now 749 and counting, place value on community co-operation through their support for this local cultural enterprise. The availability of performance opportunities, the variety of events and availability of excellent facilities is the dividend the Co-op delivers back to our shareholders, which together we share with the community at large.

The Acadia Cinema Building is the historic, literal and figurative centre of Wolfville — home to film, theatre, dance and music. Our presenters, performers, volunteers and technicians come together under the ACADIA marquee to provide live performance and first-run films in the Al Whittle Theatre, and in our second space – Studio-Z. As you see from the detailed list of facility bookings in Appendix B, the variety of events this past year is legion.

2015-16 board activities have included:

- theatrical lighting upgrades, hearing assist audio system added
- securing funding for operations, including new support from the County of Kings
- supporting and employing our part-time theatre manager
- maintaining and improving the Acadia Cinema building with our co-owners, Just Us Coffee Roasters Co-op. This past year has seen a major refit of our joint revenue-earning apartment.

Our top priorities as a board remain as before:

1. Reducing our debt
2. Find additional revenues by better promoting the theatre building as a rental venue
3. Actively seek community investment from volunteer effort, share sales and donations

On behalf of your board, I express sincere gratitude to our community volunteers and technical advisors – you personify cooperation. Thanks as well to building co-owners Just Us Coffee Roasters for their ongoing co-operation maintaining and improving our joint asset. And especially to theatre manager Mary Harwell for her professional management, presenter relations and problem solving. Together we'll continue to operate and improve the Al Whittle Theatre in 2016-17.

Corporate Secretary's Report

As of June 30, 2016 the ACC had 749 shareholders holding a total of 4,762 shares.

During the fiscal year July 1, 2015 – June 30 2016, 48 shareholders purchased 89 shares in a Nova Scotia Equity Tax Credit share sale.

Proceeds from this sale helped purchase a wireless hearing assistance system for the AI Whittle Theatre, as well as several LED fresnels (theatre lights). We are planning to have a new ETC share sale, which would close Feb 28, 2017. Proceeds would go towards air handling upgrades and equipment upgrades and storage.

In an effort to improve communication with shareholders we have continued a mid-year financial update and news of events. The most effective way for us to do this was via email. If you did not receive this update, we likely did not have your current email address. If you could send me a note to fred.chipman@gmail.com I will update our records.

Building Committee Report

The primary building focus of the 2015 / 2016 year has been the renovation of the apartment over the café. This space is jointly owned by Acadia Cinema Co-op and Just Us Coffee Roasters Co-op. Improvements consisted of new windows and insulation, a new kitchen, new bathroom fixtures and a refreshing of the paint. The apartment has been rented to two Acadia students since May 1, bringing in an increase in shared revenue income.

As well there has been some improvements to the new downstairs control booth, and some other minor maintenance. We are currently investigating conversion of the upstairs storage into office space for future rental, and adding additional storage in the upstairs booth to compensate.

Governance & Human Resources Committee

The Committee completed a new Governance Manual for ACC, approved by the Board of Directors in February, 2016. It fits within the framework of our current ACC By-laws (Dec. 2002). However, as is recommended by the Office of the N.S. Inspector of Co-operatives, those By-laws are lean. As a result, many matters are covered by Board policies and procedures, which are identified and put into context in this new Manual. It is intended to serve as: a procedural guide for the Board; a reference guide for Shareholders; and an introduction to our Co-op -- its mission and how it operates -- for potential shareholders and board members. [Note: Gwen Phillips was a tower of strength and clarity in this process, and the Committee will miss her greatly!]

Finance Committee

Financial Highlights

Highlights of the Acadia Cinema Co-Ops finances for 2015/16 are described below. Financial statements for the fiscal year ending June 30, 2016, including a Notice to Reader provided by T.C. Jones Chartered Accountants Inc. follow.

Debt / Apartment Renovations. On June 30, 2015 (previous fiscal year-end) ACC's total debt was \$58,904, consisting of; ACC's portion of the mortgage (\$20,604), the balance on a shareholder loan (\$38,300), and an interest free loan from Fundy Film (\$1000). As of June 30, 2016, these balances stood at \$35,103 (mortgage), \$32,267 (shareholder loan) and the Fundy Film loan was paid in full. As a result ACC's total outstanding debt stood at \$67,370 as of June 30, 2016, an overall increase of \$8,466 during the year. The increase in ACC's portion of the mortgage is a result of a transfer of \$20,433 in the principal owed from Just Us over to ACC. This transfer was made in an agreement with Just Us as payment for ACC's portion (50%) of the costs for a major renovation to the apartment. The rent charged for the apartment was increased once these much needed renovations were complete.

The relatively small net increase in debt of \$8,466 in 2015/16 does not represent a change in ACC's focus on debt reduction. In 2015/16 the interest expense was \$2549, a substantial decrease since 2009/10 when the interest expense was just over \$17,000. This reduction has been vital to setting ACC on a path of long term financial sustainability, which includes the flexibility to make investments such as the apartment renovations.

Revenues from Rental Income. Rental income for 2015/16 of \$63,306 is up from \$61,767 in 2014/15. Rental income continues to grow steadily, with 2015/16 being 6.9% above the five year average of \$59,201 over the period of 2010/11 thru 2014/15. That period includes 2013/14's record year of \$68,173 in rental income.

Government funding. 2015/16 was the final year of a three year operating grant (\$10,000 per year) from the Province of Nova Scotia's Operating Assistance to Cultural Organizations program (Department of Communities, Culture & Heritage). Fortunately ACC's application for this grant was approved this year, securing this important source of operational funding for three more years (through 2018/19). The Town of Wolfville also continues to support the ACC, having provided an operating grant of \$3,713 for 2015/16 from its Community Partnership Program.

Operations contribution to support capital / debt financing. When reviewing the *Statement of Operations* in the financial statements, it is important to note that the amortization of government assistance (within revenue) and the amortization expense (depreciation) are non-cash accounting entries. Adjusting the deficiency of \$8,607 (shortfall of revenue relative to expenses) reported for 2015/16 to account for these non-cash accounting entries provides a more direct picture of the operational results for the year;

This result makes 2015/16 the fifth consecutive year that operational funds were sufficient to make a substantial contribution to debt reduction.

Share Sales. The community continues to show its commitment to the ACC by purchasing shares with \$8900 of equity was raised through share sales in 2015/16. As in past years, shares purchased were eligible for a 35% tax credit through the N.S. Equity Tax Credit program. These funds were used to acquire a hearing-assist system, upgrading some stage lighting, and make a contribution to debt reduction.

Outlook for 2016/17. Maintaining revenues at levels similar to recent years, controlling ongoing operational expenses while keeping on top of needed repairs and maintenance, and debt reduction remain the primary objectives as the Board continues to move the ACC along a path of long term financial sustainability.

Theatre Manager's Report

Highlights from July 2015 to June 2016 at the AI Whittle Theatre:

- Maintained healthy rentals for the year, and surpassed our budget projection.
- Fundy Film decided to restructure this year and as of January 2016 they have been replaced by Fundy Cinema-which is being run by Noemi Volovics. They continue to screen films on Sundays and Wednesdays and we will continue to work with them to make sure the Whittle remains affordable and technologically relevant in the ever-changing world of digital cinema.
- Ongoing maintenance work on the building and equipment.
- Continued fiscal responsibility.
- Capital upgrades including three more new LED Fresnel stage instruments, new DMX cables to replace damaged cables, New Listen system for hearing impaired.
- General work on the downstairs booth including adding more electrical outlets. We continue to run all shows from downstairs in order to increase the event manager awareness of problems and maintain a physical presence in the room with the audience.
- General repairs and maintenance for equipment in the theatre and the studio (eg. Bulbs, DMX cables, projector filters, projector lamp, fluorescent ballasts replaced as necessary)
- Continued co-operation with café to provide beneficial services to our mutual customers.
- Continued efforts to enhance communications with our shareholders, presenters, performers and audiences include:
 - Twitter account is up to 949 followers at this time.
 - We have approximately 1,142 "Likes" on Facebook
- Revised ACC governance manual was accepted by the board and is available to help and explain the structure of the ACC organization to new board members and interested members.
- New lighted exterior poster window was installed with the help of the Just Us building improvement funds raised through the NT Live events at the theatre.
- Cooperation between ACC, Devour the Food Film Fest and Telefilm Canada allowed us to do four special screenings of short films on December 20 for the shortest day of the year celebration. This cooperative effort attracted a new audience and helped us collect about 60 pounds of food and \$155 for the Wolfville area food bank at Christmastime.
- Worked closely with Just Us to move forward with apartment upgrades and repairs to improve our building asset and create a new revenue stream with the rent from that apartment.
- Reapplied and got approved for another 3 years operational grant from the NS Department of Culture & Heritage (\$10,000/year)
- Applied for a new grant from Kings County to help fund new lighting fixtures.
- Created a great event (April 29) to celebrate the contribution that Fundy Film, especially Bill Zimmerman and Susan Hauer--brought to the Acadia Cinema Cooperative and to thank them for their hard work and participation over so many years, now that they are no longer as actively involved.

As of June 30, 2016 our organization had:

- 749 Shareholders holding 4,762 shares
- An enthusiastic and active group of volunteers, supporters and a dedicated board of directors.
- 3 years remaining on an approved 3-year funding commitment of \$10,000/year from NS Tourism, Culture and Heritage.
- A Place of Amusement License valid until Dec 2016.
- A part-time manager

The studio was also used regularly at no charge for board meetings for ACC and various committee meetings, as well as being the green room for the theatre for most theatrical and musical events.

Jack's Gallery in the lobby continues to be a venue for a range of exhibits throughout the year with monthly shows that highlight emerging and established artists in a quiet public and well-lit environment.

Upcoming bookings

By fiscal year-end (June 2016), the theatre had upcoming bookings for the 2016-2017 fiscal year consisting of:

- Valley Summer Theatre's seventh season booked for 6 weeks with ***Goodnight Desdemona Good Morning Juliet, Hallelujah and Wingfield's Inferno***
- ***Edalene Theatre***'s musical theatre camp booked for a week in August for a production of ***High School Musical*** and for two other exciting musical productions scheduled for November 2016 & April 2017. Edalene is also scheduled to conduct theatre classes in the studio on Monday evenings and Tuesday afternoons in the fall.
- ***Deep Roots Music Festival*** booked on September 24 for all day workshops and concerts September 24.
- Anchor tenant, ***Fundy Cinema*** bookings for their fall series from Sept 11 through December 11, 2016 on most Sunday's and Wednesdays through the fall.
- ***Night Kitchen***'s continued bookings for the first Saturday of the month every 2-3 months.
- ***Devour! The Food Film Fest*** booked for November 2-6 for a week-long celebration of food and film, including multiple film screenings and workshops.
- ***Broken Leg Theatre***'s booking for their fall show, with plans to continue their tradition of another show in February and one in June
- ***Just Us Coffee Roasters*** continues to present the Front Row Events from the National Theatre in London, with events scheduled almost every month through the fall and winter
- ***Gentlemen's Chorus*** scheduled for another carol sing concert in December.
- ***Banff Mountain Film Fest*** scheduled to return in January 2017
- ***Acadia Cinema Cooperative*** plans to host the Academy Awards again on Feb.26, 2017.
- ***Wolfville Theatre Collective*** scheduled to return with a classic play (***Death of a Salesman***) in October and another classic play in March.
- ***Lighthouse Theatre*** booked for most of a week in November to put on ***Creely Mountain Law***
- ***Off the Leash Theatre*** booked to bring back the one-man version of ***A Christmas Carol*** for one night in December.

Ken Shorley

Ken is a diverse percussionist who specializes in the hand drumming traditions of the Middle East and India. His quest for beautiful sounds has carried him to many places, including India, Indonesia, Turkey, UK, USA, and across Canada.

Based in Wolfville, Nova Scotia, Ken is an avid player and teacher of Indonesian gamelan (bronze percussion ensemble). His group, Mindful Flower Gamelan, is the first of its kind in the Maritimes, performing traditional and contemporary music for gamelan degung.

In recent years, Ken has been a featured performer at the Halifax Jazz Festival, Sound Symposium, Prismatic Festival, Lunenburg Folk Harbour Festival, Deep Roots Music Festival, CanWest Cabaret Festival, and on national broadcasts for CBC Radio 2.

In addition to composing for his hand-drumming group, Ken Shorley Trio, he has created works for TorQ Percussion Quartet, autorickshaw, mezzo-soprano Paula Rockwell, Talambra, Mindful Flower Gamelan, Quey Percussion Duo, Acadia Theatre Company, Festival Antigonish, Acadia University Percussion Ensemble, and the Nova Scotia Youth Orchestra.

Ken's current projects include directing the Gamelan and World Drumming courses at Acadia University, leading the 10-piece Turko-Balkan party dance band, ORO! Orkestra, and performing in the world music group, ASHK, with the three multi-talented Nasr sisters. He has produced several CDs of original music, as well as the instructional DVD, RhythmWise - a collaboration with his guru, the South Indian master percussionist, Trichy Sankaran.
